

**MEMORANDUM OF UNDERSTANDING**

This Memorandum of Understanding (the "MOU") is entered into 22-09-22 (the "Effective Date"), by and between **Eduspark International Pvt. Ltd.** with an address of 501, 5th floor, Interface 11, Off. Link Road, Malad (West), Mumbai – 400 064 and **Government College Arki, Tehsil Arki, Distt. Solan, 173208** also individually referred to as "**Party**", and collectively "the **Parties**."

WHEREAS, the Parties desire to enter into an agreement to provide services for the execution of Himachal Pradesh Kaushal Vikas Nigam English, Employability and Entrepreneur (HPKVN EEE) project.

**Eduspark International Pvt. Ltd.** – is a Mumbai based company focusing on bridging the gap between the unemployed youth and the requirement of skilled support services in various sectors through structured interface. With their various offerings for the education sector, they aim to reduce the massive gap between the industry requirements and availability of skilled manpower by creating specific vocational and skill development education models to enhance the industry readiness and knowledge of students, thereby providing them with the necessary skills to make them employable.

**Government College Arki, Tehsil Arki, Distt. Solan**, Govt. College Arki, established in 1994, has proven itself to be the educational landmark of District Solan and is imparting education at the undergraduate level in all the three streams, viz., Science, Arts, Commerce, apart from B.C.A. – a job-oriented self-financing course – under the Choice Based Credit System. In a short span of time, this NAAC accredited "B", co-educational institution, affiliated to H.P. University.

WHEREAS the Parties desire to memorialize certain terms and conditions of their anticipated endeavor;

NOW THEREFORE, in consideration of the mutual promises and covenants contained herein, the Parties agree as follows:

1. **Purpose and Scope.** **Eduspark International Pvt. Ltd.** has signed an agreement with HPKVN to deliver the EEE program at a **Government College Arki, Tehsil Arki, Distt. Solan** to 90 final year graduating students and would like to seek support from the **Government College Arki** to
  - 1.1. Appointing a Nodal Officer who would the SPOC for all EEE related project and will provide assistance to the Eduspark team for smooth delivery of the project.

- 1.2. Providing 1 (one) classroom and 1 Lab for training of the said candidates. The classroom to have the facility of a white screen and projector or Smart Panel. The room should have the requisite furniture and the capacity to accommodate at-least 30 candidates at a time.
- 1.3. Maintenance and cleanliness of the classroom and Lab will be the responsibility of the **Government College Arki.**
- 1.4. Classroom utilization, providing separate Wash Rooms for Male & Female students.
- 1.5. Providing First AID Kit for any untoward incident.
2. **Objectives.** The Parties agrees as follows:
  - 2.1. The Parties shall work together in a cooperative and coordinated effort so as to fulfill the deliverables of the EEE Project.
  - 2.2. It is not the intent of this MOU to restrict the Parties to this Agreement from their involvement or participation with any other public or private individuals, agencies, or organizations.
  - 2.3. This MOU is not intended to create any rights, benefits, and/or trust responsibilities by or between the Parties.
3. **Non-Disclosure.** The parties hereby agree that during the term of the agreement, the parties shall not use, commercialize or disclose Confidential Information to any person or entity. Upon termination, or at any time upon the request of the Disclosing Party, the Receiving Party shall return to the Disclosing Party all Confidential Information, including all notes, data, reference materials, sketches, drawings, memorandums, documentation and records which in any way incorporate Confidential Information.
4. **Term.** This Agreement shall commence upon the Effective Date, as stated above, and will continue until the Closure of this project.
5. **Financial Terms.** Eduspark International agrees to pay an amount of INR 6000/- (Six Thousand Only) per batch to the following account(s):
