MEMORANDUM OF UNDERSTANDING

between

Govt. Degree College Arki, (UtkrishtMahavidyalya)

And

Government Degree College Barotiwala, Baddi, Solan

Govt. Degree College Arki came into existence in 1994 AD. Since its inception, it has established itself as a premier educational institution in District Solan. It offers undergraduate courses in all three major streams, i.e. Science, Arts, and Commerce; along with BCA and PGDCA (job-oriented self-financing courses), and Post Graduate courses in History and English. This coeducational, NAAC-accredited "B" college, affiliated with HP University, has quickly developed into a learning centre offering quality education to students in the predominantly rural Arki region.

Government Degree College, Barotiwala came into existence through HP Govt. notification EDN -A- Kha (1)-1/2015 dated 29 May 2015. It became functioning on 10 June 2015 with the beginning of the academic session 2015-16. The college was functioning at Government Senior Secondary School Barotiwala for almost 7 years. The new campus building was inaugurated in September 2022. It offers undergraduate courses in all two major streams, i.e. Arts, and Commerce. The institution is located in the Baddi - Barotiwala - Nalagarh (BBN) Region, which has emerged as one of the biggest industrial hubs in the State. Individuals from various parts of India currently live in this region. Govt. College Barotiwala demonstrates the

diversity and unity of the nation by offering high-quality education to a varied student population.

This Memorandum of Understanding (hereafter referred to as MoU) is being laid down for collaboration between Govt. Degree College Arki (Utkrish Mahavidyalaya) and Government Degree College Barotiwala, Tehsil Baddi, Dist. Solan, in the areas of mutual interest. The goal is to foster collaboration, provide opportunities for enriching experiences, and facilitate the advancement of knowledge based on reciprocity, best effort, mutual benefit, and frequent interactions. This partnership also aims to enhance both organisations' technological, social and cultural relations. This document outlines a broad framework for the partnership that may be periodically revised. This MoU may be modified by mutual consent of the authorised officials of the institutions. This MoU shall become effective upon signature by the authorised officials and will remain in effect until mutually modified or terminated on mutual consent by any of the partners.

Areas of Collaboration:

1. Collaboration in academic programs; both institutions will collaborate by sharing resources, particularly in all academic fields and other emerging areas of mutual interest.
2. Both institutions will accommodate students and faculty for visits to their premises including research facilities and laboratories as per their policy.
3. Faculty/staff exchanges, visiting programmes, and student internships or exchange programmes will be conducted on mutually agreeable terms.
4. Both colleges will organise joint job-fairs, seminars, workshops and conferences as per mutual consent.
5. Any other joint academic and research activities viewed as mutually beneficial will be conducted.

Mutual Obligations

This Memorandum of Understanding does not require the two institutions to provide funding for faculty, students, or staff from the other institution unless there are dedicated funds for that purpose.

Termination of Memorandum

This agreement can be ended immediately if both partners agree or by one partner giving the other partner written notice two months in advance.


Coordination

In order to carry out the activities outlined in the MoU incumbent Principals of both the institutions shall appoint the coordinators and share their information with each other. The coordinators will mutually plan and execute the activities.






